STATUTE OF THE OIC MEDIA FORUM

We, the representatives from the Member States of the Organization of Islamic Cooperation (hereinafter referred to as the OIC),

CONVINCED that our common civilization values, belonging to common ethic and cultural identity, affiliation with the common regions, consisting of Member States of the OIC constitute significant opportunities for development of media and communication expertise in the Muslim World within the broad framework of political, economic, social and cultural development;

REAFFIRMING our commitment to the principles of the OIC Charter, universal human rights and necessity of dialogue among civilizations, which provide the basic grounds for the cooperation among the media members and institutions of the OIC States and their counterparts worldwide;


PURSUANT to Resolution Number 5/9 INF on the establishment of the OIC Media Forum adopted by the Information Ministers of the OIC Meeting held in Libreville, the Republic of Gabon on April 2012 and the Resolution 1/39 INF adopted by the 39th CFM held in Djibouti on 17 November 2012 on the endorsement of resolutions by the 9th ICIM;

ACKNOWLEDGING the important role that media should play in the process of development in the OIC Member States;

DETERMINED to consolidate the cooperation among media of the OIC States, and to cooperate in developing of our respective societies; advancing great values of Islamic civilization resting inter alia on the principles of justice, tolerance and non-discrimination, at the international level;

ACTING as Founding States of the OIC Media Forum,

ADOPTED the present Statute of the OIC Media Forum.



Article 1 Definition

"OIC Media Forum" established by this Statute in accordance with Article 25 of the Charter of the OIC shall be an affiliated institution of the Organisation of Islamic Cooperation.

OIC Media Forum is an inter-governmental, non-commercial, non-partisan umbrella media organization, uniting international media organizations and government agencies from the member-States of the OIC, operating in the OIC region and media organization.


Forum is registered as a legal entity under the law of Turkey.

In the present Statute, the following terms shall have the means set opposite each one of them:

- a. The OMF means OIC Media Forum
- b. The General Assembly means the General Assembly of the OIC Media Forum
- c. The Executive Board means the Executive Board of the OIC Media Forum
- d. The Secretariat means the Secretariat of the OIC Media Forum
- e. The Executive Director means The Executive Director of the OIC Media Forum
- f. The OIC means the Organisation of Islamic Cooperation
- g. The Member States mean OIC Member States which have acceded to the OIC Media Forum in line with Article 5 of this Statute
- h. The CFM means OIC Council of Foreign Ministers
- i. The Islamic Summit Conference means Summit of Kings and Heads of States and Governments of OlC Member States

Article 2 Headquarter

- 1. The Headquarter of the Forum shall be located in Istanbul, Turkey. The host country shall provide all necessary facilities for its smooth functioning including providing premises, equipments and necessary benefits, concessions, diplomatic immunities and privileges similar to those granted to subsidiary and specialised organs framed in the Article 34 of Charter of the Organisation of the Islamic Cooperation which should be determined by bilateral agreement between the OMF and the hosting state.
- 2. The OMF may, under a General Assembly resolution and upon a proposal from the Executive Board, establish in any other country, centres, offices or institutions which are subsidiary to it or are under its supervision.



Article 3 Legal Status

The OMF shall enjoy the status of fully-fledged legal entity as an international organization, using its full legal capacity to exercise its functions and fulfill its objectives as defined in the Statute.

Article 4 Objectives

The objectives of the Forum are:

- 1. To contribute to the strategic role of OIC in the world affairs
- 2. To promote international public awareness and understanding of noble Islamic values, true image of Islam in line with the Paragraph 12 of Article 1 of the OIC Charter,
- 3. To promote equality of access to reliable public information worldwide and encourage the highest standards of journalism that emphasise accuracy, balance, fairness and accountability,
- 4. To become a focal point and to ensure greater exchange of news and information among media members around the world and sharing of similarities and differences in social, cultural, political and media experiences,
- 5. To analyse the current state of the Member States' media and its development, and facilitate its professional improvement; such as capacity building for media professionals,
- 6. With the aim of capacity improvement of the Islamic media, to discuss the current issues affecting the development of the Member States' media market by providing a platform for discussion on the role and position of the OIC in the global development and peace building processes; and by creating opportunities for building new partnerships and developing innovative cooperation models.
- 7. To strengthen the media with the purpose of reaching the goals of the right to know, right to access to information and freedom of expression by respecting human dignity and human rights in accordance with the Paragraph 12 of Article 1 of the OIC Charter,
- 8. To undertake an active role in combating Islamophobia, racism and discrimination against Muslim communities and minorities in line with the Paragraph 16 of Article 1 of the OIC Charter, and promote a political culture and tolerance in OIC Member States,
- 9. Utilizing different media outlets to defend the holy city of Al-Quds-al-Sharif, its Arabic and Islamic identity as well as its holy sites.

10. To raise awareness worldwide about occupation of Islamic lands and preservation of Islamic heritage.

11. To promote the fostering of noble Islamic values concerning moderation, tolerance, respect for diversity, preservation of Islamic symbols and common heritage and to defend the universality of Islamic religion.

Article 5 Membership

- 1. Every Member State of the OIC may become a member of the OMF upon signing the Statute, and after it has completed legal and legislative formalities in accordance with its national procedures and informed in writing to the Secretariat of the OMF. Members of the OMF are obliged to pay annual membership fees to the Secretariat.
- 2. A Non-Member State or observer of the OIC, which is not the member of the OMF, may apply for the status of observer at the OMF. Regional and international organisations may enjoy the status of observer, after submitting the request to and upon the approval of the General Assembly.
- 3. Decisions on granting observer status to an international organization and Non-Member States shall be taken by the General Assembly by consensus and on the basis of the agreed criteria determined by the General Assembly. Observers shall not have the right to vote.

Article 6 Organs of the OMF

Organs of the OMF are:

- 1. General Assembly
- 2. Executive Board
- 3. Secretariat

Article 7 General Assembly

- The General Assembly should comprise of ministers responsible for matters within the mandate of the OMF or their representatives, who are nominated by the respective Member State. The General Assembly shall hold ordinary session within the framework of the OIC Information Ministers Meeting once it has been added on its agenda.
- 2. Each member shall have one vote.

3. The General Assembly shall be field for the following issues



- 3.1 To discuss issues and adopt decisions on the general policies pursued by the OMF,
- 3.2 To evaluate the implementation and follow-up of its policy decisions,
- 3.3 To review progress in the implementation of resolutions adopted at previous sessions,
- 3.4 To discuss, evaluate and approve the report by the Executive Director on the work of the Executive Board,
- 3.5 To discuss, evaluate and approve the report of the Executive Director on the work of the Secretariat and approve the budget of the OMF,
- 3.6 To elect the members of the Executive Board.

Article 8 The Executive Board

- 1. The Executive Board consists of 9 members, 8 of whom are elected for a four-year term by the General Assembly among the members, whose candidature is put forward by the Member States and an Executive Director.
- 2. The Executive Director, shall be appointed by the host country serving for a four-year term and renewable once (a total of eight years).
- 3. The Executive Board shall work to promote communication among member-states, media organizations and media members and provide framework for consultations and exchange of views and the dissemination of information that may have common significance to the members.
- 4. As a rule, the Executive Board convenes its regular meeting in the Headquarter of the OMF. Upon the decision of the Executive Board, meeting can also be held in one of the Member States on the basis of hospitality provided by the Member States and organizations.
- 5. The Executive Board holds its regular meetings at least once a year.
- 6. The Executive Board shall overview and follow-up the implementation of the resolutions, decisions and recommendations of the General Assembly, provide evaluations and recommendations to the work of the Secretariat. The Executive Board oversees the preparatory work conducted by the Secretariat for the General Assembly and adopts its provisional agenda.
- 7. The Executive Board audits the budget of Secretariat via Financial Control Committee regulated in paragraph 1 of Article 12.

- 8. Executive Director shall act as representative of the OMF in international arena. S/He shall, on the basis of opinion provided by the Secretariat, represent the OMF during negotiations with other national and international entities and sign agreements on behalf of the OMF.
- 9. Executive Director shall report on the work of the Executive Board to the General Assembly.

Article 9 Secretariat

- 1. The Secretariat, acting as an executive body of the OMF, is responsible for implementation of decisions adopted by the relevant bodies of the OMF.
- 2. Secretariat shall be chaired by the Executive Director.
- 3. The Secretariat shall directly supply the members with the working papers and memoranda through appropriate channels, within the framework of the resolutions, decisions and recommendations of the General Assembly;
- 4. The Secretariat shall also designate the agenda of the OMF for the General Assembly's meetings by negotiating with the members through appropriate channels.
- 5. The Secretariat is responsible for organizing Executive Board meetings, conferences, training courses, workshops, seminars and other undertakings, carried out by the OMF.
- 6. The Secretariat provides technical, operational as well as expert support for the functioning of the main bodies of the OMF.
- 7. The Secretariat operates at the Headquarter of the OMF. Secretariat services shall be provided by Republic of Turkey Office of the Prime Minister, Directorate General of Press and Information.
- 8. The staff of the Secretariat shall be appointed by the host country. Other Member States may nominate staff to the Secretariat provided that their salaries and all other expenses are met by the nominating country and nominated staff is approved by the host country.

Article 10 Budget

1. The budget shall be prepared for two years by the Executive Board and shall become effective each year as of January 1st up to the end of December of the same year. It shall be executed after its adoption by the General Assembly, in accordance with the provisions of the Financial Regulations of OMF.

2. Executive Director shall prepare a biannual report on the financial term which s/he shall submit to the General Assembly together with budget and closing account at its following session subsequent to the end of the financial year. The report shall include his/her proposals on the implementation of the budget as well as his/her observations on the closing account.

Article 11 Finance

- 1. The budget of the OMF is formed from the membership fees paid in accordance with the guidelines produced by the Secretariat; voluntary grants by the Member States, OIC institutions, other intergovernmental and non-governmental organizations and individuals, provided both for implementation of specific projects or the overall activity of the OMF.
- 2. Other financial resources of the OMF shall include:
 - (a) Fund-raising for special projects,
 - (b) Proceeds of the sales of publications, products, services relating to the OMF's field of competence.
- 3. The Secretariat shall manage finances of the OMF in accordance with the budget approved by the General Assembly.
- 4. The budget of the OMF is to be used on sustaining the operation of the Secretariat, convening the General Assembly sessions and Executive Board meetings, implementation of developmental projects with participation of all members as well as other specific projects in line with the OMF's objectives.

Article 12 Accounts

- 1. The Executive Director shall, under the supervision of the Executive Board, prepare the closing account and submit it to the General Assembly at its following session subsequent to the end of the financial term. The Executive Board shall appoint a Financial Control Committee made up of representatives from three Member States, one of whom shall be from the host country, for a two-year period and on a rotational basis, to audit the accounts of the OMF, and to ensure sound management of the OMF headquarter and its offices. The Committee may seek assistance of experts in related fields, if needed.
- 2. The Financial Control Committee shall have the right to examine all the relevant books and records and to request the Executive Board or the officials of the OMF to provide any information if deems necessary for the performance of its duties. Accounts shall.

be audited by the Financial Control Committee on an annual basis so as to verify the accuracy of the budget and the accounts.

3. The Financial Control Committee shall submit its report to the Executive Director who shall refer it to the Executive Board with his/her observations thereon. The Executive Board shall submit the report to the General Assembly at its following session.

Article 13 Withdrawal and Suspension

- 1. Any member may withdraw from the OMF by sending a written notification to the General Secretariat, to be circulated to all members. Withdrawal of any member shall be effective from sixty (60) days after the Secretariat has notified the General Assembly.
- 2. Any member applying for withdrawal shall be bound by its obligations until the end of the fiscal term during which the application of withdrawal is submitted.
- 3. A decision to suspend a member from the OMF shall be taken by the General Assembly by consensus and in the absence of consensus by a two-thirds majority of the members in accordance with the regulations laid out by the General Assembly on this matter.

Article 14 Amendment

- 1. Any Member of the OMF may propose amendments to the Statute.
- 2. Any proposed amendment to the Statute is to be submitted to the Executive Board through the Executive Director.
- 3. Any amendment to the Statute is to be approved by the Executive Board by a two-thirds majority of the members. Such an amendment is to be presented to the members of the OMF at least thirty (30) days before the forthcoming Executive Board Meeting.
- 4. Final amendments to the Statute shall be adopted by the General Assembly by consensus and in the absence of consensus by a two-thirds majority of the members present.
- 5. An amendment to the Statute becomes effective for all Members of the OMF when two-thirds of the members have notified the Executive Director in writing of their approval of such modification.
- 6. The Executive Director is to notify all Members of the OMF of the effective date of such modification.

Article 15 Interpretation


Any dispute that may arise in the interpretation, application or implementation of any Article in the present Statute shall be settled peacefully, and in all cases through consultations, negotiations, reconciliation or arbitration.

Article 16 Ratification and Entry into Force

- 1. This Statute shall enter into force upon completion of legal and legislative formalities of thehost country. Entry into force for other Member States of the OIC shall be regulated as per Article 5/1 of this Statute.
- 2. The instruments of ratification of this Statute shall be deposited at the General Secretariat of the OIC.

Article 17 Language

Official languages of the OMF shall be English, Arabic and French.

The General Secretariat of the Organization of Islamic Cooperation (OIC) presents its compliments to all OIC Member States and Observer Members, and has the honour to attach herewith a note verbale from the Republic of Turkey stating that, with reference to the Statute of the OIC Media Forum (OMF), an OIC affiliated institution adopted at the 40th Session of the OIC Council of Foreign Ministers, Article 9, Sub-paragraph 7 of which, states that "The Secretariat operates at the Headquarters of the OMF. Secretariat services shall be provided by Republic of Turkey Office of the Prime Minister, Directorate General of the Press and Information", The Republic of Turkey informs that based on the Decree of Council of Ministers of Turkey, which regulated the organization and functions of "Republic of Turkey Office of the Prime Minister, Directorate General of Press and Information" referred in Article 9, Sub-paragraph 7 of the Statute has been abolished with the "Presidential Decree on Amendments to the Constitution" No: 703 dated 9 July 2018 and rights and responsibilities of that Directorate has been transferred to "Presidency of the Republic of Turkey, Directorate of Communication" with the "Presidential Decree on the Organization of Communication Directorate" No: 14, dated 24 July 2018. The Republic of Turkey notifies that the reference to the "Republic of Turkey Office of the Prime Minister, Directorate General of Press and Information" in Article 9, sub-paragraph 7 of the OMF Statue should, therefore, be understood as reference to the "Presidency of the Republic of Turkey, Directorate of Communication".

The General Secretariat avails itself of this opportunity to renew to all OIC Member States and Observer Members the assurances of its highest consideration. ω . S
